Access Point Services That Most PEC Centers Are Offering

Almost 70% of ALL existing PEC "UPS shipping & processing centers" have added AP services to their existing UPS service over the last four years and all New PEC Centers have been adding AP services as they sign up to be PEC Authorized Shipping Providers.

There are some reminders that all PEC Centers need to know when offering UPS AP Services at their locations:

- You must scan in all AP packages you receive from the UPS driver within 30 minutes of receipt to get paid for handling AP packages
- You must scan out packages as customers come pick-up AP packages
- Your store must check the ID of the person picking up the AP package(s)
- Release package to person that matches name on package
- You need to check your UPS message inbox each day to see if your store needs to return any "aged- out" package to the driver that day. An aged-out package means that your store has kept and waited on the customer to pick-up their package for 7 days. At this time an aged package is given back to UPS. Yes you still get paid for these packages even though the customer never picked them up.

Your Monthly PEC Shipping Report (MSR) Review

The 2nd page of your Monthly Shipping Report (shown at left) provides profit & data analysis on many different items:

The first page that prints is a copy of your monthly invoice that you retain for your records. This monthly package activity data transmits to PEC atomically the first business day of the month – as long as you turn on your computer and open the Total Shipping Software. If you have not transmitted you monthly data to PEC by the 10th day of the following month – PEC will send you a reminder notice to the email address we have on file for your store to remind you that your monthly invoice is due. The third page is more data on type or packages shipped from your store.

- 1. The "scorecard" at the top of the report provides you with your retail package volume in comparison to last year's totals. This can help you identify ROI and patterns following advertising and marketing investments, industry changes, etc. You can measure these changes monthly, year-to-date, and by annual totals.
- 2. The Retail Package section provides you with freight and accessorial metrics for the packages you create labels for. Here you can get a quick look at net profit and profit per package for a specific month or for the entire year. Average profit per package has been growing every year due to UPS's annual price increases. This specific store's report is showing an average of \$5.42 average for the month of December and \$5.88 per package average overall for the year.
- ■3. The Total Profit Detail section provides you with similar metrics, but includes other income avenues like RPDO packages, 3rd party packages, and miscellaneous/packing charges. Again, you can see the totals for the month or the entire year. Some centers that also offer packing have anywhere from \$ 15.00 -\$ 30.00 average profit per package based on how much and type of packing they offer their customers.
- 4. The Package Weight analysis provides a monthly and annual breakdown of the weight of all retail packages (and store packages) processed. You'll notice most packages are lower weight and more easily stored/handled. The majority of all packages shipped are under 20 pounds and smaller in size. On the other hand: the larger the package, the more it weighs and the farther it is being shipped have the highest profit.

Of course, there are many other reports contained in your Total System Software that includes: the UPS manifest, a daily receipts report, a monthly summary report and the data analysis report which can be ran using customer date ranges of your choice.
